## INVITATION FOR TENDERS

*Thorough repair (thermo-modernization) of Municipal Kindergarten No. 11 “Sonechko” at Kurchatova str., 12, Pokrov city, Dnipropetrovsk region, Ukraine*

*Department of Education of the Executive Committee of Pokrov City Council*, hereinafter referred to as “the Employer”, intends to use part of the proceeds of a loan and grant from the Nordic Environment Finance Corporation (NEFCO) towards the (cost) of Project “*Energy-efficiency improvement in Pokrov city of Dnipropetrovsk region*”.

The Employer now invites the Contractors to submit their tenders for the following contract to be funded by the loan and grant, aimed at purchase of:

### **Lot 1: Financed by loan plant and related works**

*«Development of design documentation with passing of the expertise and designer’s supervision, supply of equipment and materials, performance of the whole complex of installation and dismantling works, including repair and finishing works of entrance groups and porches, restoration of damaged heat insulation of the heating network, replacement of ladders of emergency exits, disposal and removal of dismantled materials in accordance with environmental requirements».*

### **Lot 2: Financed by grant plant and related works**

*«Supply of equipment and materials, performance of the whole complex of installation and dismantling works, including replacement of exterior windows and doors, facade insulation, installation of blind area, insulation of a soft roofing of the building, arranging weather dependent regulation in the boiler room».*

Tenders are invited for both lots – tenders for one lot only will be rejected. Each lot must be priced separately. Plant supplied under Lot 2 will be exempt from taxes. To be qualified for the award of a Contract, Tenderers must satisfy the following minimum criteria:

- the Tenderer, has the financial, technical and production capability and capacity necessary to perform the Contract, and Tenderer’s average annual revenue in the previous **three** years was at least **two** times greater than price of his tender. In case of tender submitted by JVCA, the leading partner should demonstrate at least 50% compliance with the requirement;
- the Tenderer has satisfactorily delivered similar plant and works to other Employers and completed at least **five(5)** similar Contracts in the recent **five** years;
- the Tenderer or its agent will be able to carry out warranty obligations;
- the Tenderer is not bankrupt or under bankruptcy procedures according to the national legislation or regulations;
- in the case of a Tenderer offering to deliver plant under the Contract which the Tenderer does not manufacture or otherwise produce, the Tenderer has been duly authorised by the plant’s manufacturer or producer to deliver the plants in the Employer’s country.

In preparation of their offers, the Tenderer should take into account that the works in this Contract will tentatively start on **June 2020** and continue to **August 2021**.

Tender documents, upon request from prospective Tenderer, will be sent by email free of charge in electronic format (PDF file). If requested to send documents in the written form, the documents will be sent by Employer to Tenderer on terms and conditions agreed by the two.

All Tenders must be accompanied by a Tender security in the form of tender-securing declaration whose form is provided in Tender Document. The purpose of Tender security is to ensure the Tenderers are serious about their participation.

The winning tenderer will have to provide performance security from a reputable bank acceptable to NEFCO.

Tenders must be delivered to the office at the address below before **06.04.2020 at 12:00 a.m.**, at which time they will be opened in the presence of those Tenderers' representatives who choose to attend.

Pre-tender meeting of Tenderers with the Employer's representatives for visiting the project sites and discussion of technical and logistical issues will be held on **04.03.2020 at 11:00 a.m.** at the address: **Dnipropetrovsk region, Pokrov city, Tsentralna str., 48.**
